Independent Author Policy

Thank you for considering our bookstore for placement of your book. Because we are approached many times throughout the year by authors hoping we will sell their books, it has become necessary to develop a written policy so that all expectations are clear.

Technology has made publishing easier, often without traditional professional editing, proofreading, and evaluation of marketing and distribution. Consequently, the number of books we are asked to consider for our shelves has risen dramatically. No bookstore can carry every published title, whether from a major publisher's list or self-published by a local author. Many factors influence booksellers' decisions; of the most importance is whether the book will sell at this store and to our customers. As with all books, when deciding whether or not to stock, we consider the subject, production quality, retail price, and discount available from the publisher.

We review thousands of books each year. We decline many books, including those by well-known and award-winning writers, if they are not a good match for our store, but it is never a pleasant task to decline when dealing directly with an author rather than simply reviewing a catalog.

Due to the economics of carrying and selling books by independent authors, it is our policy to take such books on consignment. If we decide to carry your book, we will ask you to sign a contract that includes the following terms:

- 1) Books may be left at The Galaxy Bookshop on consignment for a period of up to six months.
- 2) During these six months, the author may contact The Galaxy Bookshop by email at the end of each month to check the stock status and may invoice us for any books sold.
- 3) In the case that the book has been selling steadily, the author will be given the opportunity to sign a new contract.
- 4) After six months, the author will retrieve any unsold stock and provide us with a final invoice, if necessary.
- 5) The Galaxy Bookshop will pay invoices within 30 days of receipt of invoice.
- 6) If the author does not pick up books at the end of six months, the books become the property of The Galaxy Bookshop and we will donate at our discretion.
